

**FARMVILLE PARKS AND RECREATION DEPARTMENT PLAYER
CONTRACT / CODE OF CONDUCT
2025 Adult Soccer**

All adult soccer players and coaches shall be guided by the following:

1. No player or coach shall refuse to abide by a staff or official's decision.
2. No player or coach shall be guilty of objectionable demonstrations of dissent at an official's decision by throwing the ball or other equipment.
3. No player shall, other than team captain, discuss with a staff or official in any manner, the decision reached by staff or official.
4. No player shall be guilty of using unnecessary rough tactics in the play of the game against the body, and persons of an opposing player.
5. No player or coach shall at any time, lay a hand, push, shove, strike, or threaten to strike other players, staff, or officials.
6. No player or coach shall be guilty of verbal abuse upon any staff or officials for any real or imaginary wrong decision or judgement.
7. No player or coach shall be guilty of physical attack as an aggressor upon any player, staff, official, or spectator.
8. No player or coach shall be guilty of allowing team followers (ex. Wives, relatives, friends) to heckle any official, scorekeeper, or league supervisor. It will be the coach's responsibility to control crowds behind his team bench. If the manager cannot control the crowds, he may obtain assistance from the league supervisor.
9. I hereby give my permission for my photo/video to be taken and used for Farmville Parks & Recreation publications and all forms of Farmville Parks & Recreation Social Media.
10. I hereby give my permission to participate in the adult soccer program. I know that with any sport there is possibility of serious injuries. I, therefore, will assume all responsibilities for any accident or injury that may occur.

Penalty: Ejection from the game by staff or official. A player who is ejected from a game will be required to leave the facility promptly and be suspended for a minimum of one (1) game. If a player does not wish to leave after ejection, the staff or official will forfeit the game. **Managers please see that your player leaves promptly.** If said player is ejected the second time, he may be suspended for the remainder of the season. If circumstances so warrant, player may be suspended from participation in any competitive program, and facility of the Farmville Parks and Recreation Department indefinitely!

NOTE: Justification is not a point of argument concerning code of conduct.

FARMVILLE PARKS AND RECREATION RELEASE OF LIABILITY FOR ADULT PARTICIPANTS

IN CONSIDERATION OF myself being allowed to participate in any way in the Farmville Parks and Recreation Department related events and activities, the undersigned acknowledges and agrees that:

By participating in the activities involved in these programs offered by Farmville Parks and Recreation, I will be exposed to the risk of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19), including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. FOR MYSELF I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for myself participation; and,
2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my readiness for participation and/or in the program itself, I will remove myself from the participation and bring such attention of the nearest official immediately; and, I myself, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Farmville Parks and Recreation Department; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
3. I, for myself and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releases from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.

I, FOR MYSELF HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY REGISTERING FOR 2025 FARMVILLE FOOTY FRENZY 6V6 SOCCER TOURNAMENT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

Both player and manager of each team must sign this contract. PLEASE PRINT CLEARLY!
